 - ➤ What are Recovery Services?

- How are they different from "regular" services? They are not mandated by the state. Recovery services are available to aid in the education process if students are struggling with the covid shut downs. Determining if the student requires Recovery Services -look at IEP goals, regression, benchmark assessment scores, to determine the student needs. Recovery services are intended to be short term services. If the student's needs change dramatically, then amending the IEP is encouraged to help the student in the most impactful way.
